Bid Format: Please provide a lump sum base bid based on the complete Scope of Work as outlined in the Bid Package, as well as separate pricing for Bond premiums, alternates and unit prices as indicated.

All bids must include all work as necessary to provide a complete and operating system whether or not specifically mentioned in the Scope of Work or Bid Documents. Bids must be based on the complete Scope of Work as outlined in the Bid Package and be based on the complete set of plans and specifications as listed, no exclusions or exceptions should be made.

Bids must be based on the project schedule or phasing plan as provided, including premiums and provisions for overtime and quick-shipment of materials as necessary. Temporary services and other provisions necessary to accommodate the phasing schedule must also be included.

Base bids must be based on the products and materials specified, but "or equal."
